2025 Breeders' Directory and Puppy Register



To be listed on the Breeders' Directory, you must be a paid-up member of the BGV Club.

All breeders must ensure that their stud dogs and brood bitches are of breeding age, healthy and, in the case of PBGVs, both parents must have a DNA test unless they are hereditary clear.

- I/We are aware of "The Animal Welfare Regulations (England) July 2018: The breeding and selling of litters" and how it will affect me/us as detailed on www.bgvclub.co.uk/breeders.
- I/We wish to be included in the 2025 BGV Clubs Breeders' Directory.
- I/We understand that for £20.00 per breed my/our details, as shown below, will be on the BGV Club website for 2025 and included in BGV Voice and leaflets handed out at Crufts, Discover Dogs etc. If requested, free listing per breed, including photo, may be made on the Puppy Register website page for a 12-week period. For this one-off annual fee, the BGV Club Secretary will also refer enquirers to me/us when I/we have a litter.
- I/We understand that failure to comply with all aspects of the BGV Club Breeders Directory and BGV Club Code of Ethics may result in removal from the Breeders Directory.
- I/We understand that it is the responsibility of the breeders to arrange and/or pay for a suitable assessment of the dog prior to rehoming if requested by the BGV Club.
- I/We are aware that contractual obligations with puppy buyers are for the lifetime of the dog and not linked with membership of the Breeders Directory or the BGV Club.

For PBGVs: (protecting against Primary Open Angle Glaucoma) -

- For (1) <u>Clear to Clear matings producing Clear</u>, and (2) <u>Affected to Clear producing</u> <u>Carriers</u>, puppy buyers must be given proof of the DNA status of their puppy based on the results of the parents' DNA tests. However, in the case of (3) <u>Carrier to Clear matings</u>, where a DNA test has not been done, new puppy owners must agree to do this prior to any future breeding to ascertain whether or not their PBGV is a Carrier.
- All puppies of Clear to Carrier matings must be DNA tested prior to export.
- A BVA eye test is highly recommended for all breeding stock prior to mating.
- Breeders' Directory members will not engage in breeding the following combination of dogs: Affected to Affected, Affected to Carrier, Carrier to Carrier.
